

RIDER'S RELEASE AND INDEMNITY AGREEMENT

I, the undersigned, being of lawful age, acknowledge that horses, even with careful supervision, are unpredictable and that horseback riding is an inherently dangerous activity that may result in property damage, injury or death. Knowing and appreciating this danger, I desire for myself and/or my child/legal ward to ride horseback and/or receive horseback riding lessons from Ingrid A. Knippelmeyer d/b/a Blue Spring Farm and The School District of Menomonee Falls and the Menomonee Falls Community Education and Recreation Department. By participating in horseback riding and horseback riding lessons and executing this Rider's Release and Indemnity Agreement, I accept and assume all risk of loss or injury which may occur as a result of such lessons or other equestrian activities participated in.

In consideration of the horseback riding lessons provided, and for other good and valuable consideration, receipt of which is hereby acknowledged, I do hereby release and discharge Ingrid A. Knippelmeyer d/b/a Blue Spring Farm, The School District of Menomonee Falls and Menomonee Falls Community Education and Recreation Department, the horse owner, the owner of the riding facility or equipment and their employees or agents and all other persons or corporations, associations or partnerships ("Releasee") from any and all claims, actions, suits, causes of action, and demands of any nature, whether at law or in equity, arising from or alleged to arise from any accident or other occurrence involving me, members of my family or my guests, during or in connection with the horseback riding lessons or other equestrian activities and in connection with the condition of the horse, equipment or premises used for such lessons or activities.

I do hereby promise, agree and covenant that I will never, at any time, sue or bring any action against Releasee by reason of any claim for damages, whether for property damage, personal injury, or death arising out of the horseback riding lessons, whether such damage arises from the conduct of the lessons or from the condition or actions of the horse, equipment, or riding facility at which the lessons are conducted. I hereby indemnify and hold the Releasee harmless from any and all liability, loss or damage Releasee may suffer as a result of any accident, casualty or event involving me or members of my family or my guests which may result from the negligence of myself, members of my family or my guests.

I warrant and represent that I will be bound by and obey the directions and rules set forth by the Releasee, that I have made an inspection of the facilities, equipment and horse and rely upon my own skill, judgment and ability and that I understand that Releasee makes no warranty or guaranty of any nature with respect to the condition of the horse, equipment or the riding facility. I further declare and represent that no promise, inducement or agreement not herein expressed has been made to me, that this Rider's Release and Indemnity Agreement contains the entire agreement between the parties and that the terms of this Rider's Release and Indemnity Agreement are contractual and not a mere recital.

NOTICE: A person who is engaged for compensation in the rental of equines or equine equipment or tack or in the instruction of a person in the riding or driving of an equine or in being a passenger upon an equine is not liable for the injury or death of a person involved in equine activities resulting from the inherent risks of equine activities, as defined in section 895.481(1)(e) of the Wisconsin Statutes.

HAVING CAREFULLY READ THE FOREGOING RELEASE AND KNOWING THE CONTENTS THEREOF, I SIGN THE SAME AS MY OWN FREE ACT.
